### Introduction:

The College established the 40 seats Bachelor Dental Surgery Courses in 2000 which got recognized in the year 2004 by the Ministry of Health and Family Welfare. In the year 2012 Manubhai Patel Dental College started the Master of Dental Surgery courses in 5 subjects with 15 seats and got recognized for MDS courses in the year 2015. Manubhai Patel Dental College has been one the most sought after colleges in gujarat from Dental Courses.

### Institutional Weakness :

Manubhai Patel Dental College is currently unable to accept students from foreign nations and out of state students due to the restrictions of the law due to which the diversity of students sufferes and hence the lack of the International Student Cell. The college does not have an active Alumni association, but the college is trying to encourage its alumni to be proactive.

### Institutional Opportunity :

Manubhai Patel Dental College has the opportunity to incerease its seat capacity of the Bachelor of Dental Surgery program from 40 to 100 and Master of Dental Surgery program from 15 seats to 27 seats and is working towards the goal of increasing its capacity to maximum possible.

### Institutional Challenge :

Manubhai Patel Dental College faces the challenge where the the demand of students pursuing Dental Sciences is going down with a lot of colleges in Gujarat and across India unable to fill their seat capacity. The college also faces issues with certian students admitted by the government who are unable to pay the fees of the course and as a result some of them leave the course mid way or end up finishing the course without paying the regular fee amount.

### Criteria wise Summary

### Curricular Aspects :

Manubhai Patel Dental College is affilaited M.K Bhavnagar University and is regulated by the Dental Council of India. The University adopts the syllabus as published by the Dental Council of India. Manubhai Patel Dental College ensure that its faculty train the students as per the regulations of the DCI and achieve the outcomes as required by the Dental Council of India. In addition, the college conducts continuing dental education programs for the students of the college and encourages even the undergraduate students to participate in research work.

The college has not been able to admit foreign students since the Supreme Court of India disallowed foreigners from taking admission under the NRI category. ### Answer:

For a institute to produce competent doctors with skill and knowledge there needs to be a shift from the conventional teaching learning methods. This leads to shifting of teacher centric approach to student centric approach. Facilitating adult learning in a way that is efficient and helps in retention of knowledge in students is desired at every institute. In the quest of the same Manubhai Patel Dental College had introduced the concept of interactive learning to our faculty first through a 2 day compulsory teacher training programme in the college in the year 2016.

This helped us in understanding various modes of small group and large group teaching. Integrating various techniques like snowballing, buzz groups, quiz etc. in small group and didactic lectures, student symposium etc. in large group has inspired towards creating more student friendly learning environment.

Moreover, learning in the times of the pandemic has really been affected immensely. Thus the flipped classroom technique was tried during these times to facilitate self directed learning in the pre clinics by the faculty members. Various data in form of videos, suitable articles [usually reviews], power point presentations etc. are provided to the students prior to the online sessions. In the offline mode this acts like an adjunct to physical demonstration, discussion in small groups etc. The knowledge acquired by the students is then assessed and students are given feedback of their performance.

Clinical learning incorporates discussion and demonstrations in small groups on the patient. Students learn by verbal and non verbal communication of the facilitator with the patient. This helps them *apply* and *analyze* the *cognitive* data they have acquired in the pre clinical learning. The clinical performance of final year students is formatively assessed in the final posting.

Lectures are planned ahead of session keeping the learning objectives of every session in mind. This helps in formulating a proper lesson plan for students. The learning objectives are planned in a way to stimulate various levels of Bloom's taxonomy. This helps the faculty members in pushing the students towards better learning and help them in reaching on the top of the Miller's pyramid.

Each of these classrooms is equipped with Projectors and Air-Conditioned. Continuous updating of all the facilities is done to provide clinically-oriented and technologically advanced learning. Digital Dental Radiographic facilities like IOPA, OPG, RVG are available. Dental Microscopes, Hard and Soft tissue lasers, various Implant surgical equipments, Orthodontic software, are made available for the students. Sterilization Committee has made the Sterilization protocols which is to be maintained at higher clinical standard. An In-house made patient management software takes care of the patient documentation and planning for comprehensive management of patient needs.

The institution has satellite clinics, in the heart of the City, to provide oral health care. The college has a fully equipped mobile Dental van with 2 dental chairs and other instruments to facilitate for the fore mentioned vision. There are laboratories in various departments which help the students to improve their practical skills. Well-equipped Pre-Clinical laboratories with Phantom Heads are provided in Conservative Dentistry department to enable the Undergraduate students to learn and train properly with hands on experience before attending patients. Prosthodontic Department laboratory, histopathological laboratory and clinical laboratory are used for the patient care. The entire college is Wifi enabled.

# TITLE OF PRACTICE - Detailed Yearly Academic Planning

## **Objectives of the Practice** :

Manubhai Patel Dental College believes in thorough planning and rolling planning system that can be monitored well. The objectives of of this practice are :

- 1. Systematic achievement of completion of syllabus.
- 2. Well planned lectures and teaching by virtue of advance teaching plans.
- 3. Professional approach to teaching, learning and evaluation.

**The Context** : In 2010, the Teaching and Learning Committee noticed that while the teaching activity of the institute ensured that the syllabus was completed as per the rules of the Dental Council of India, it was observed that teaching activity at the start of the year was slow and casual and towards the end of the year was fast and brush through. There were also issues where the syllabus for the internal examinations was declared just a few days before the examinations due to which the students were facing problems in examination preparations.

## The Practice :

- 1. Prior to the beginning of each academic session all the department heads are given the Teaching time table, latest syllabus, examination schedule of the year, student posting data and asked to submit subject wise the detailed academic date wise lecture plan, practicals plan, syllabus for the internal examinations for each subject and work quota for students. The data will be detailed to include the name of the lecturer and the topic to be taken by the lecturer.
- 2. All data is submitted by the Department Heads and reviewed by the Dean for any changes.
- 3. Once approved. All the Data is uploaded to the College website on the individual department webpages, including the google calender of the department so that the students and the faculty can refer.

## **Evidence of Success :**

The practice has brought tremendous professionalism to the departments of the college and made life simpler for the students of the institute. The lectures are able to plan all their lecture topics in advance and in a thorough manner. While the students can not be prepared for lecture topics as well be sure about the examination syallabus. All the faculty adhere to the schedule which is monitored by the Teaching and Learning Committee.

#### **Problems Encountered and Resources Required :**

During the practice, some problems were encountered due to unexpected leaves of staff on the dates of their scheduled duties. As a result a strict protocol for leaves was put in place such that, prior to the approval of leave, a thorough explanation is sought about delegation of duty and lectures during leaves to as not to affect the schedule of the teaching activity at the institute.

## Answer:

Manubhai Patel Dental College & Hospital has established the goals and abilities established by DCI as learning goals and attributes for both BDS and MDS programs and has uploaded the same on the website. MPDC's pedagogical approach aims to provide education that improves knowledge, skills and attitudes. This allows for integrated overall development at the personal and professional level and carefully implements the same by a structured and well planned teaching-learning process. The Teaching and Learning Committee prepares timetables year-wise and the departments prepare Teaching schedules and Lesson plans. All departments adhere to the schedule and ensure that the curriculum is completed in time. Apart from conventional teaching methods such as chalk & talk, and Didactic lectures, PPT and Video presentations are followed for lecture delivery.

In the practical training, students are first trained in a preclinical laboratory using a model and a phantom head to master dental skills before entering the clinical department. Upon entering the clinic, teachers will guide the clinic until they are confident enough to deal with the patient and the actual situation. Students can gain hands-on experience in all aspects of sterility and infection control, as well as clinical dentistry. Problem-solving and patient-oriented learning are also useful for diagnosis, treatment planning, and scientific evaluation. Integrated interdisciplinary education helps to comprehensively plan and treat patients.

College conducts 3 internal assessments . Various parameters are set which assess the core competencies of a dental graduate. The written exam evaluates the knowledge of the students while practical exam evaluates the knowledge, skill and attitude of the students. A minimum of 50% in each is considered a pass. University Examination is conducted at the end of each year for theory, practical, and viva and upon completion of the undergraduate training program, graduates will acquire the specified abilities and be able to start courier as a dentist.
